

Whereas, among others, Shri Akhtar Ahmed Baba S/o Abdul Rashid Baba R/o Rehbab Sahib, Ali Kadal, Srinagar, was recommended for selection as Accounts Assistant in Finance Department under OM Category in District Cadre Srinagar and State Cadre in Main Selection List by the Services Selection Board vide their Nos. referred to above;

Whereas, among others, Shri Akhtar Ahmed Baba S/o Abdul Rashid Baba R/o Rehbab Sahib, Ali Kadal, Srinagar, was asked to exercise his option as to whether he intends to join the post of Accounts Assistant in District Cadre Srinagar or State Cadre within seven days from the date of issuance of the notice vide this office No. DGAT/E-III/G-21/82 dated 21.05.2015;

Whereas, Shri Akhtar Ahmed Baba, S/o Abdul Rashid Baba R/o Rehbab Sahib, Ali Kadal, Srinagar, did not respond to the notice within the stipulated period. Instead Shri Faizan Ahmad S/o Gh. Mohi-ud-Din Wani R/o 159-A, Green Park, Hyderpora, Bypass Srinagar who figures at Serial No. 1 of Waiting List in District Srinagar under OM Category produced an affidavit wherein Shri Akhtar Ahmed Baba has undertaken that he neither wants to join in District Srinagar nor in State Cadre;

Whereas, a final notice vide this office No. DGAT/E-III/G-21/156 dated 25.08.2015 was served to Shri Akhtar Ahmed Baba wherein he was directed to file his objections within a period of seven days from the date of issuance of the said notice as the Department is going to consider the deputation of Shri Faizan Ahmad S/o Gh. Mohi-ud-Din Wani R/o 159-A, Green



Park, Hyderpora, Bypass Srinagar for one year's ACC training in Accountancy Training Institute, Srinagar in his place;

Whereas **Shri Akhtar Ahmed Baba** did not respond to the final notice issued to him within the stipulated period of seven days;

Whereas, consequent upon causing/availability of the vacancy under OM Category in District Srinagar, Shri Faizan Ahmad S/o Gh. Mohi-ud-Din Wani R/o 159-A, Green Park, Hyderpora, Bypass Srinagar becomes entitled for deputation of one year's ACC training in Accountancy Training Institute, Srinagar in place of Shri Akhtar Ahmed Baba S/o Abdul Rashid Baba R/o Rehbab Sahib, Ali Kadal, Srinagar.

In view of above and as approved by the Competent Authority, Shri Faizan Ahmad S/o Gh. Mohi-ud-Din Wani R/o 159-A, Green Park, Hyderpora, Bypass Srinagar, is deputed for one year's ACC training in Accountancy Training Institute, Srinagar (six month's theoretical and six month's practical) by corresponding cancellation of selection/deputation for one year's ACC training of Shri Akhtar Ahmed Baba S/o Abdul Rashid Baba R/o Rehbab Sahib, Ali Kadal, Srinagar. During the training period he shall be entitled to stipend as admissible under rules.

After successful completion of one year's ACC training in Accountancy Training Institute, Srinagar, he shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800. His service shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".

The selectee shall report to the Principal, Accountancy Training Institute, Srinagar, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case the selectee fails to join within the stipulated period of 21 days, his appointment shall stand cancelled without any further notice.





The appointment shall be subject to the following conditions:-

- (a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.
- (b) The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.
