

Order Nos. 342-Acctts of 2015 dated 26.08.2015, issued under endorsement No. DGAT/E-III/G-21/181 dated 26.08.2015 and 343-Acctts of 2015 dated 27.08.2015, issued under endorsement No. DGAT/E-III/G-21/183 dated 27.08.2015 are hereby withdrawn.

Consequent upon approval of the Competent Authority and in-partial modification of Order No. 339-Acctts of 2015 dated 25.08.2015, issued under endorsement No. DGAT/E-III/G-21/177 dated 25.08.2015, it is further ordered that:-

- the delay of 18 days in joining Northern Zonal Accountancy Training Institute, Jammu in favour of Smt. Divya Sharma D/o Shri Ganesh Dutt Sharma, R/o Mohinder Nagar, Canal Road, Jammu, figuring at Serial No. 11 of Annexure-A of the above referred Order, under caption, "District Cadre Jammu" is **condoned** as recommended by the Principal, Northern Zonal Accountancy Training Institute, Jammu vide her letter Nos. A/Zonal/J/2015/440 dated 26.08.2015 and A/Zonal/2015/463 dated 02.09.2015 by corresponding withdrawal of cancellation of her selection / deputation for one year's ACC training;
- the selection/deputation of Smt. Nisha Bakshi D/o Amardeep Bakshi R/o Smailpur Jammu, figuring at Serial No. 9 of Annexure-B to the above mentioned order, under caption, "District Cadre Jammu", is cancelled in view of the fact that she is already in Govt. service and has given an undertaking in the shape of an Affidavit that she shall not claim to join against the post of Accounts Assistant in Finance Department;



(iii) Shri Sikander Singh, S/o Shri Yash Pal Singh, R/o Satrayian R.S.Pura, Jammu and Shri Anil Singh Chib S/o Balak Singh R/o Satowli R.S.Pura Jammu figuring at Serial Nos. 1 & 3 respectively in Waiting List for District Cadre Jammu under OM Category are deputed to the Northern Zonal Accountancy Training Institute, Jammu for undergoing one year's ACC training (six month's theoretical and six month's practical) as recommended by the Services Selection Board vide their Nos. SSB/Sel/Secy/015/3589-94 dated 31.03.2015, SSB/Sel/Secy/2015/3597-3602 dated 31.03.2015 and SSB/Sel/Secy/2015/7700-02 dated 14.08.2015. During the training period they shall be entitled to stipend as admissible under rules.

After successful completion of one year's ACC training in Northern Zonal Accountancy Training Institute, Jammu, they shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800. Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".

The selectees shall report to the Principal, Northern Zonal Accountancy Training Institute, Jammu, within a period of 21 days from the date of issuance of this order alongwith the following certificates/ documents in original:-

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case any selectee fails to join within the stipulated period of 21 days, his/her appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

(a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.



(b) The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.
