Subject: Policy on transfer / posting of Government employees belonging to the J&K Accounts Service and J&K Subordinate Accounts Service.

GOVERNMENT ORDER No: 168- F OF 2014,
D A T E D : 14 - 07 - 2014.

The transfer Policy applicable to the members of J&K Accounts Service and J&K Subordinate Accounts Service issued vide Government Order No. 235-F of 2010 dated 26.08.2010, is hereby withdrawn, and the revised Transfer Policy applicable to the members of these services is issued as under. However, the general principles for the transfers / postings of Government employees as laid down in the said Government Order read with the Government Order No. 861-GAD of 2010 dated 28.07.2010 shall remain the same.

- i. All the posts in J&K Accounts Service in the category of Junior Scale Accounts Officers and J&K Subordinate Accounts Service i.e., Assistant Accounts Officers, Accountants and Accounts Assistants are classified into "A" and "B" categories forming Annexures "A", "B", "C" and "D" respectively to this Government Order.
- ii. Present places of posting/ stay lists of all the officers/ officials shall be the roster for their posting from "A" to "B" posts and vice versa.
- iii. Orders once issued must be strictly complied with. If it is considered that any order requires modification for some compelling reason it shall be done only after obtaining approval of the next higher authority. Reversal of transfer orders once issued, must be a very rare event and to be

resorted to only in exceptional cases for which reasons shall be recorded in writing.

- iv. Transfers shall ordinarily be ordered in the first month of the financial year i.e., in April every year.
- v. Transfers for Ladakh region shall be made as per the policy laid down for such transfers by the Ladakh Affairs Department. However, all the posts borne on J&K Accounts Service and J&K Subordinate Accounts Service existing in Leh/ Kargil Districts shall be deemed to exist in "B" category.
- vi. Where the officers/ officials who have to move first are indicated, they shall handover the charge of their offices within seven days of issue of the order. In case, the charge is not handed over on the expiry of seven working days, it shall be deemed to have been handed over automatically. This provision will not, however, apply to such cases where there are specific instructions for giving immediate effect to the transfers.
- vii. The minimum tenure of a Government employee on a post shall be of two years and a maximum of three years.
- viii. Pre-mature transfers wherever un-avoidable in the interest of administration shall be ordered with the prior approval of the Administrative Department for reasons to be recorded.
- ix. An employee holding any post may be transferred even before the completion of minimum tenure if:-
 - a. the performance of the employee is found to be below job requirement and if there are sufficient grounds for initiating enquiry or disciplinary proceedings against him/her; or
 - b. it is not in the public interest or in the interest of administration to allow the employee to continue on a post for a full tenure; or

c. the transfer sought on health grounds should be supported by Medical Certificates issued by the duly constituted Medical Board. However, the officer/ official concerned, before approaching the concerned Medical Board, should approach the concerned authority competent to order his transfer / posting, through a representation, who will refer his / her case to the concerned Medical Board for their recommendations after proper medical examination of the concerned officer/ official.

- x. Transfers, postings, promotions and deputation in respect of the members of J&K Accounts (Gazetted) Service shall be effected by the Director General Accounts & Treasuries with the prior approval of the competent authority (Administrative Department).
- xi. Transfers, postings, promotions, placements and deputation in respect of Assistant Accounts Officers shall be effected by the Director General, Accounts & Treasuries.
- xii. Transfers, postings and deputation of Assistant Programmers, Accountants, Head Assistants, Senior Assistants, Head Cashiers, Accounts Assistants, Data Entry Operators, Cashiers, Drivers, Jr. Assistants, Van Cleaners, Orderlies and Chowkidars shall be made by the Directors of Accounts & Treasuries Kashmir / Jammu within their respective Divisions / Organization. In the case of inter organizational transfers the powers for such transfers shall vest with the Director General, Accounts & Treasuries.
- xiii. No officer/ official, posted in an office/ division in "A" category shall be, on his / her transfer posted to any office / division in the said category.



- xiv. As far as possible, officers/ officials presently posted in an office / division, shown in "B" category shall not be on their transfer posted in an office/ division shown in the said category.
- xv. While deciding posting of an officer / official awaiting orders of adjustment / posting or attached in an office for reasons whatever, the previous posting held by him / her prior to his / her attachment, shall be taken into consideration for the purpose of classification irrespective of the period of his / her attachment.
- xvi. Transfers/ Postings of the officers/ officials in exceptional circumstances and under administrative exigencies shall be made in relaxation of the provisions of the policy with prior approval of the Administrative Department.




