Subject:-Implementation of Centralized Personnel Information System (CPIS)-
Providing of the information to the empanelled vendors thereof.

To go ahead in the matter of implementation of employee's and pensioner's data base commonly known as Centralized Personnel Information System(CPIS), the Government/Information Technology Department has empanelled the below mentioned vendors for capturing/verification of data of employees and pensioners:- (i) M/s i-Kraft , 12 Post Office Lane Hyderpora, Srinagar , Kashmir. (ii) M/s i-Locus, 12 Factory Road, Upper Soura , Srinagar, Kashmir. (iii) M/s, Wapmerr, Indo Kashmir Complex, Nowabazar, Srinagar, Kashmir (Common Collection Centre, 12 Post Office Lane Hyderpora, Srinagar , Kashmir, Land Line help Desk No. 0194-2433512).

It has been brought to the notice of the Finance Department that most of the DDOs are not cooperating with the empanelled/designated vendors. This has been viewed seriously by the authorities in the Finance Department. It is as such impressed upon all the Treasury officers/Drawing and Disbursing Officers to co-operate with the vendors and provide the requisite information in a prompt manner.

The DDOs/Treasury Officers shall give a certificate to the vendors about the employees/pensioners/family pensioners details in the following manner :-
"Certified that the CPIS data of _____ number of employees/pensioners/family pensioners have been furnished to M/S _____ duly completed for preparation of computerized data base of all J&K State Government Employees and Pensioners/family Pensioners".

Treasury Officers are advised to entertain the salary bills from DDOs for the salary of August 2013 only if they provide a copy of this certificate.
