Reference: Government Order No103-F of 2023 dated 19.03.2024.

CIRCULAR

- a) The JKPaySys shall remain operational on 29th March 2024 up to 2:00 PM for generation/submission of payment bills to treasuries.
- b) The DDO's shall generate/submit bills after observing all prescribed codal formalities and any lapse on part of rejection made at treasuries for want of codal formalities/miscalculation will be sole responsibility of DDO concerned.
- c) The DDO's shall submit the hard copies of the bills to concerned treasuries by or before 4:00 P.M.
- d) The Bills/ Claims so presented are liable to special audit wherever required.
- e) Treasury Officers shall entertain the claims from DDO's duly complete in all respect up to 04:00 P.M. and subsequently submit the liability by or before 5:30 P.M. to respective Directorates who in turn furnish the liability to Director General Accounts & Treasuries by 6:00 P.M.
- f) Payments Authorized on 30.03.2024 are processed well in time to avoid last minute rush on various applications as per special arrangement put in place by RBI and issued by this Directorate vide Circular No. DGAT/COMPOE-Ku/2/2021-01/146 dated 19.03.2024.
- g) Treasury Officers will not leave the treasuries unless successful information regarding acknowledgement approved, debit notification is received from RBI. Any information regarding acknowledgement rejected, return notification for the payments processed on last day of Financial Year i.e. 30.03.2024 (if any) from RBI is communicated to respective DDO0's/ NIC well in time for correction/rectification and in no case submit the file to RBI beyond prescribed time on 30.03.2024.
- h) All Treasuries of UT of J&K including Civil Secretariat Treasury and sub Treasury, New Delhi shall remain open on Sunday 31.03.2024 exclusively for purpose of receiving Government receipts only.
