Whereas, Shri. Ali Mohammad Dar, Accounts Assistant, on qualifying SAC-I Examination vide J&K Public Service Commission's Notification No. referred to above has been elevated as I/C Accountant vide order No.142-Acctts of 2013 dated 05.03.2013;

Whereas, the official could not be regularized with his batchmates for his alleged involvement in Handloom Development Scam Pulwama in Case FIR No.31/2010 at Crime Branch Kashmir;

Whereas, Senior Superintendent of Police, Crime Branch Kashmir vide letter No.DGAT/E-III/PF-1866/33 dated 11.09.2015 was requested to communicate latest status of his case who vide No.CBK/R-11327 dated 16.09.2015 intimated as under:-

**"The Investigation of Case FIR No.31/2010 P/S Crime Branch Kashmir has already been concluded and the charge sheet of the same has been presented before the competent Court of jurisdiction on 03.01.2015, against the accused persons. However, Sh. Ali Mohammad Dar, I/C Accountant, Forest Division Shopian is not figuring in the list of accused."**

Whereas, the case of I/C Accountant was examined by the Departmental Promotion Committee in its meeting held on 02.03.2016 and recommended to regularize the Accountant retrospectively from the date his batchmates have been regularized; and

Now, in view of the above and as recommended by the Departmental Promotion Committee, sanction is accorded to the regularization of Shri. Ali Mohammad Dar, I/C Accountant, Forest Division Shopian as a Member of Kashmir Subordinate Accounts Service, Class-II (Accountants) in Pay Band-2 Rs.9300-34800 + G.P. Rs.4220/= w.e.f. 05.03.2013 or his actual date of assumption of charge as I/C Accountant whichever is later.

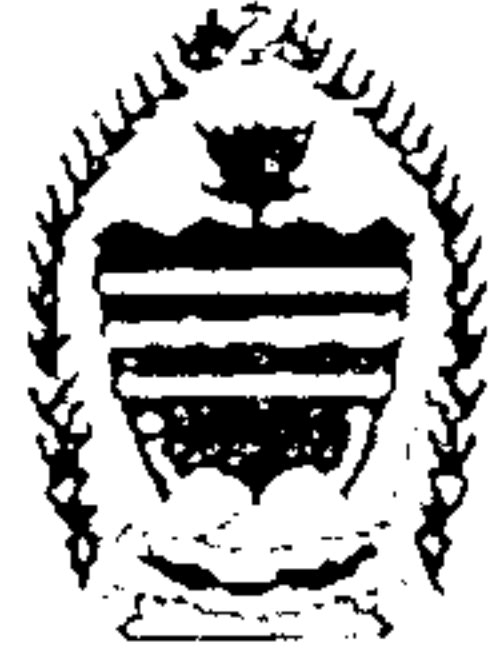




