Whereas, the Director, Accounts & Treasuries, Jammu vide letter No. DATJ/Adm/2017-18/4852-54 dated 28.12.2017 reported that Mr. Shiv Kumar Sharma, Treasury Officer, Bhallessa has been arrested by Police (Vigilance Organisation) in case FIR No. 45/2017 P/S VOJ for demanding and accepting a bribe of Rs. 5000/ from the complainant Mr. Mohammad Rafiq Zagar R/O Chilli Bala Tehsil Bhallessa, Gandoh District Doda for release of his pension claim.

Whereas, the Director, Accounts & Treasuries, Jammu submitted his report based on the report submitted to him by the District Treasury Officer, Doda and SSP (UDR) Vigilance Organisation, Jammu.

Whereas, the Director, Accounts & Treasuries, Jammu vide letter No. DATJ/Adm/2017-18/4901-02 dated 01.01.2018 intimated that District Treasury Officer Doda vide letter No. DTO/D/2017-18/1251-53 dated 01.01.2018 informed that Senior Superintendent of Police (UDR) Vigilance Organisation, Jammu vide No. SSP/UDKR/2017/5117-20 VOJ dated 30.1.2017 has intimated that Mr. Shiv Kumar Sharma, Treasury Officer, Bhallessa has been granted interim bail by the Hon'ble Court of Special Judge Anti Corruption, Doda till 17.10.2018 vide Order dated 30.1.2017.

Whereas, Mr. Shiv Kumar Sharma, Treasury Officer Bhallessa, as per the aforementioned report of Vigilance Organisation has remained in Police custody from 27.12.2017 to 30.12.2017 i.e. more that 48 hours.

Now, therefore, in view of the above, Mr. Shiv Kumar Sharma, Accounts Officer (Treasury Officer, Bhallessa) is hereby placed under suspension with immediate effect. During the period of suspension he shall remain attached in the office of Director, Accounts & Treasuries, Jamimu.

Mr. Anish Singh, District Treasury Officer, Doda is appointed as Enquiry officer to enquire into the matter. He shall submit a detailed

enquiry report to the Directorate General of Accounts & Treasuries through Director, Accounts & Treasuries, Jammu within a fortnight positively.
