- a) 05 vehicles sanctioned to be purchased through State Motor Garages vide aforementioned Government Order shall add to its fleet;
- b) The maintenance of the vehicles shall be provided by the State Motor Garages;
- c) The Drivers to ply these vehicles shall be provided by the State Motor Garages, however, no posts of Drivers shall be created, in any case;
- d) The vehicles shall be specifically placed at the disposal of the officers, as shown in Annexure to this Government order;
- e) On transfer of the officer outside the secretariat, the concerned officer shall surrender the vehicle to the State Motor Garages, and
- f) Any change in the allotment of vehicles shall be effected by the State Motor Garages only after seeking the consent of the Finance Department (Director General, Accounts & Treasuries).


