Whereas, the Services Selection Board, J&K vide their No. SSB/Secy/Sel/2016/20539-45 dated 30.11.2016 recommended 65 candidates for selection as Accounts Assistant in District Jammu;

Whereas, these selectees were deputed for undergoing one year's ACC training in NZATI, Jammu vide Order No. 10-Accts of 2017 dated 11.01.2017 except 16 candidates whose recommendations were kept withheld by the SSB for certain prior clarifications;

Whereas, out of 49 selected candidates who were deputed for one year's ACC training the below mentioned 13 candidates failed to join in the training Institute within the stipulated period:-

Whereas, the Principal NZATI, Jammu vide No. A/Zonal/J/2017/970-71 dated 17-05-2017 communicated that out of these 11 selectees, 02 candidates viz; Shri Manik Arora S/o Rakesh Arora R/o Channi Himmat Jammu under OM category and Shri Yash Paul S/o Bhagwan Dass R/o Nora Jagir Akhnoor Jammu under RBA category failed to join in NZATI, Jammu within stipulated period of time;

Whereas, a notice vide No. DGAT/E-III/G-21/133 dated 08.08.2017 was served to Shri Manik Arora S/o Rakesh Arora R/o Channi Himmat Jammu under OM category and Shri Yash Paul S/o Bhagwan Dass R/o Nora Jagir Akhnoor Jammu under RBA category in District Jammu respectively to submit their objection, if any regarding cancellation of their selection and the said notice was published in "Daily Excelsior" a local daily in Jammu;

Whereas, the concerned candidate did not file any objection in this behalf within stipulated period of seven days.



In view of above, sanction is hereby accorded to the:-

- i. **cancellation of selection/deputation for one year's ACC training in respect of Shri Manik Arora, S/o Rakesh Arora, R/o Channi Himmat, Jammu under OM category and Shri Yash Paul, S/o Bhagwan Dass, R/o Nora Jagir Akhnoor, Jammu under RBA category in District Jammu respectively who failed to join in the training Institute within the stipulated period; and**
- ii. **deputation of Shri Nishant Abrol S/o Shri Suresh Kumar Abrol R/o Janipur Colony Jammu under OM Category and Shri Rajesh Jamwal S/o Shri Hardev Singh R/o Sagar Surinsar, Jammu under RBA Category in District Jammu respectively to NZATI, Jammu selected by the Service Selection Board as Accounts Assistant in Finance Department in Waiting List under relevant Category in concerned District vide its No. referred to above, for undergoing one year's ACC training in Northern Zonal Accountancy Training Institute, Jammu.**

During one year's ACC training the selectees shall be entitled to stipend as admissible under rules.

The selectees shall report to the Principal, Northern Zonal Accountancy Training, Institute, Jammu, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- i. Academic/Technical Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.





- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case the selectees fail to join within the stipulated period of 21 days, their appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
- (b) The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointees from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training in Northern Zonal Accountancy Training, Institute, Jammu, they shall be formally placed as Accounts Assistants in PB-1, ₹ 5200-20200 + Grade Pay ₹ 2800. Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".
