**Subject:- Select list of the candidate for the post of "Accounts Assistant"
(Finance Department) District Cadre Jammu.**

Order No. 116 - Accts of 2018
Dated :- 28 .03.2018

Whereas among others, Shri Jaswant Singh S/O Shri Darshan Singh R/O Satrayian R.S Pura, Jammu was selected as Accounts Assistant under OM Category in District Jammu by Services Selection Board vide their No. SSB/Sel/Secy/2015/3589-94 dated 31.03.2015.

Whereas, the Department could not depute the selectee for undergoing one year's ACC training as his recommendation was kept withheld by the Services Selection Board.

Whereas, later, among others, recommendation in his case was released by the Services Selection Board vide their No.SSB/Sel/Secy/2015/5602-05 dated 11.06.2015 and approval of Competent Authority for his deputation to undergo one year's ACC training was also obtained.

Whereas, his deputation order for undergoing the prescribed training was not issued as the Hon'ble High Court of J&K in SWP/1746/2015 and MP No. 01/2015 titled Ajay Kumar v/s State of J&K & Ors passed an Interim order and relevant part of the interim order is reproduced as under:-

"In the meanwhile, subject to objections from other side and till next date before the Bench, the selection shall not be finalized in respect of handicapped category".

Whereas, the Hon'ble High Court while disposing off the case vide its order dated 20.12.2017 ordered as under:-

"There is no representation today as well. It appears that the petitioner has lost interest in prosecuting the case. Accordingly, the writ petition is dismissed for want of prosecution".

Whereas, his case was submitted to General Administration Department vide U.O. No. DGAT/PS/DR/49 dated 08.02.2018 for seeking relaxation to operate the said selection list in respect of Shri Jaswant Singh S/O Shri Darshan Singh R/O Satrayian R.S Pura, Jammu as the selection list remains valid only for a period of one year and the delay in issuance of his deputation order was neither attributable to the selectee nor to the Department nor to the Service Selection Board.

Whereas, the Deputy Secretary to Government, General Administration Department, vide O.M.No, GDC-34/CM/2018 dated 09.03.2018 conveyed approval of the Hon'ble Chief Minister as under:-

"Sanction in relaxation of Rule 14 (5) of the J&K Civil Services Decentralization and Recruitment Rules, 2010 notified vide SRO 375 dated 21.10.2010, is hereby accorded to the re-validation of selection list for the post of "Accounts Assistant" District Jammu, recommended by the Services Selection Board vide letter No. SSB/Sel/Secy/2015/3589-94 dated 31.03.2015 read with No. SSB/Sel/Secy/2015/5602-05 dated 11.06.2015, against Item No. 840, of Advertisement Notification No. 10 of 2013, in respect of candidate namely Shri Jaswant Singh S/O Shri Darshan Singh R/O Satrayian R.S Pura, Jammu, figuring at Serial No. 21 under OM Category, beyond the date of its expiry (viz 30.03.2016) upto 30th of April, 2018".

In view of the above, Shri Jaswant Singh S/O Shri Darshan Singh R/O Satrayian R.S Pura, Jammu selected under OM Category in District Jammu vide Services Selection Board vide their No. SSB/Sel/Secy/2015/3589-94 dated 31.03.2015 is deputed to NZATI, Jammu for undergoing one year ACC Training.

The selectee shall report to the Principal, Northern Zonal Accountancy Training Institute, Jammu within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

1. Academic/Technical Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate issued by Competent Authority.
4. Permanent Resident Certificate.
5. Relevant Category Certificate.
6. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

In case the selectee fail to join within the stipulated period of 21 days, his selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- a. The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is



received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and the selectee shall have no claim of their appointment.

- b. The verification of all required certificate viz; Academic Qualification Certificates, Date of Birth Certificates, Health Certificates, Permanent Resident Certificates, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training at Northern Zonal Accountancy Training Institute, Jammu, the selectee shall be formally placed as Accounts Assistant in PB-1, ₹5200-20200 + Grade Pay ₹2800 against the post of Accounts Assistants. Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of Jammu and Kashmir Civil Service Regulations Volume-II and "Kashmir Subordinate Accounts Service, Rules".
