Sub: Deputation of Accounts Assistants (Apprentice) for one year's ACC Training.

As recommended by the J&K Services Selection Board, Jammu vide communication referred to above, sanction is hereby accorded to the deputation of **04 (Four) candidates** to Northern Zonal Accountancy Training Institute, Jammu/ Accountancy Training Institute, Srinagar, as shown against each for one year's ACC training (six month's theoretical and six month's practical).

During one year's ACC training period these candidates shall be entitled to stipend as admissible under rules.

The selectees shall report in the respective training Institutes within a period of 21 days from the date of issuance of this order along with the following certificates/documents in original:-

- i. Academic/Technical Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case any appointee fails to join within the stipulated period of 21 days, his/her appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- i. The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of

Police, CID, J&K, to whom a reference shall be made by the Principal, Training Institute, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.

- ii. The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's training at Northern Zonal Accountancy Training Institute, Jammu/Accountancy Training Institute, Srinagar, they shall be formally placed as Accounts Assistants in the PB-1, ₹5200-20200 + Grade Pay ₹2800. Their services shall be regulated under the provisions of "Rules for Admission in the Accountancy Training School for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".






