Whereas, the Secretary, Services Selection Board, Jammu/ Srinagar vide Nos. SSB/ Secy/Sel/AA/Bud/2018/5428-30 dated 25.05.2018, SSB/ Sel/ Secy/ 2018/5567-69 dated 04.06.2018 & SSB/ AA/Kup/2018/6097-99 dated 19.06.2018 conveyed that recommendations in favour of the above referred selectees are released;

Consequent upon release of recommendations by the J&K Services Selection Board, the above referred **03** selectees are deputed for undergoing one year's ACC training in the Training Institute shown against each.

These selectees shall report to the Principal, ATI, Srinagar/ NZATI, Jammu within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

1. Academic/Technical Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate issued by Competent Authority.
4. Permanent Resident Certificate.
5. Relevant Category Certificate.
6. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

In case the selectees fail to join within the stipulated period of 21 days, their selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.

- b) The verification of all required certificate viz; Academic Qualification Certificates, Date of Birth Certificates, Health Certificates, Permanent Resident Certificates, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointees from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training at ATI, Srinagar/ NZATI, Jammu they shall be formally placed as Accounts Assistant in PB-1, ₹ 5200-20200 + Grade Pay ₹ 2800(Pre-revised)/ Level-5 (29200-92300) against the post of Accounts Assistants. Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of Jammu and Kashmir Civil Service Regulations Volume-II and "Kashmir Subordinate Accounts Service, Rules".
