Whereas, among others, **Shri Nisar Ahmad Shah S/o Gulzar Ahmad Shah R/o Thune Kangan Ganderbal under RBA Category in District Ganderbal and Zaid Bin Manzoor S/o Manzoor Ahmad Shah R/o Shalteng Srinagar under OM Category in District Srinagar** were selected as Accounts Assistant (Apprentice) by the Services Selection Board vide their No. referred to above;

Whereas, recommendations in respect of the above candidates were kept withheld subject to clarification in respect of their documents from the Competent Authority;

Whereas, Services Selection Board vide No.s SSB/AA/Gbl/2018/8473-75 dated 17.07.2018 and SSB/AA/Sgr/2018/9870-72 dated 07.09.2018 released the withheld recommendations of Shri Nisar Ahmad Shah S/o Gulzar Ahmad Shah R/o Thune Kangan Ganderbal and Zaid Bin Manzoor S/o Manzoor Ahmad Shah R/o Shalteng Srinagar; *respectively.*

Now, therefore, **Shri Nisar Ahmad Shah S/o Gulzar Ahmad Shah R/o Thune, Kangan Ganderbal and Zaid Bin Manzoor S/o Manzoor Ahmad Shah R/o Shalteng Srinagar** are deputed for undergoing one year's Accounts Clerk's Course Training (six month's theoretical and six month's practical) in Accountancy Training Institute, Srinagar. During the training period they shall be entitled to stipend as admissible under rules.

The selectees shall report to the Principal, Accountancy Training Institute, Srinagar, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

1. Academic/Technical Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate issued by Competent Authority.
4. Permanent Resident Certificate.
5. Relevant Category Certificate.
6. Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

In case any selectee fails to join within the stipulated period of 21 days, his selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.
- (b) The verification of all required certificate(s) viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's training at Accountancy Training Institute, Srinagar, **they shall be placed against the post of Accounts Assistants with the condition that their service shall be governed under the provisions of SRO-202 dated 30.06.2015.** Their services shall be regulated under the provisions of "Rules for Admission in the Accountancy Training School for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".


