Whereas, among others, the Services Selection Board vide their No. referred to above recommended **Shri Idrees Ahmed S/o Mohd Shaban Batt R/o Bun Doda Near Sports Stadium Doda city and Shri Shabir Hussain S/o Khazir Mohmad R/o Chararishareef Chadoora, Budgam** subject to certain conditions.

Whereas, due to non joining of candidates from the main selection list in Districts Doda and Budgam under OM category, **Shri Idrees Ahmed S/o Mohd Shaban Batt R/o Bun Doda Near Sports Stadium Doda city and Shri Shabir Hussain S/o Khazir Mohmad R/o Chararishareef Chadoora, Budgam** become eligible for their deputation of one year's ACC training.

Whereas, the Secretary, Services Selection Board, Srinagar vide Nos. SSB/Sel/Secy/2018/**7396-98** dated 26.06.2018 and SSB/Secy/Sel/AA/Bud/2018/**9867-69** dated 07.09.2018 conveyed that recommendations in favour of these selectees are released;

Consequent upon release of recommendations by the J&K Services Selection Board, the aforementioned two selectees are hereby deputed for undergoing one year's ACC training in Northern Zonal Accountancy Training Institute, Jammu, and Accountancy Training Institute, Srinagar.

These selectees shall report to the Principal, NZATI, Jammu/ ATI, Srinagar within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- i. Academic/Technical Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.

- vi. Certificate(s) from the General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

In case the selectees fail to join within the stipulated period of 21 days, their selection shall stand cancelled without any further notice.


The appointment shall be subject to the following conditions:-

- a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, their appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.
- b) The verification of all required certificate(s) viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointees from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training at NZATI, Jammu /ATI, Srinagar, they shall be formally placed as Accounts Assistant in PB-1, ₹5200-20200 + Grade Pay ₹2800 (Pre-revised)/ Level-5 (29200-92300) against the post of Accounts Assistants. Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of Jammu and Kashmir Civil Service Regulations Volume-II and "Kashmir Subordinate Accounts Service, Rules".
