Sub: Deputation of Accounts Assistants (Apprentice) for one year's ACC Training.

Whereas, among others, **Shri Vijaydeep Singh, S/o Jagdeep Singh, R/o Neera Ramban, Shri Mudasir Ahmad Shah S/o Gh. Mohi ud Din Shah R/o Mohd Pora, Kulgam and Shri. Mubashir Mohi ud Din S/o Gh. Mohi ud Din, R/o Zawoora Baderhama, Shopian** have been selected as Accounts Assistants (Apprentices) in District Cadre Ramban, Kulgam (under OM Categories) and Shopian (under RBA Category) respectively by the Services Selection Board vide their No. referred to above;

Whereas, recommendation in respect of the said candidates were made subject to certain clarifications from the Service Selection Board, Jammu;

Whereas, the Secretary, Services Selection Board, Jammu vide their No's. SSB/Secy/Sel/2017/282-84 dated 04.12.2017, SSB/Secy/Sel/213/2017/13754-56 dated 27.12.2017 and SSB/Secy/Sel/246/2017/363-65 dated 06.01.2018, conveyed that recommendations in favour of the above referred selectees are released;

Consequent upon release of recommendations by the J&K Services Selection Board vide their communications referred to above, **Shri Vijaydeep Singh, S/o Jagdeep Singh, R/o Neera Ramban, Shri Mudasir Ahmad Shah S/o Gh. Mohi ud Din Shah R/o Mohd Pora, Kulgam and Shri. Mubashir Mohi ud Din S/o Gh. Mohi ud Din, R/o Zawoora Baderhama, Shopian** are deputed for undergoing one year's Accounts Clerk's Course Training (six month's theoretical and six month's practical) in Northern Zonal Accountancy Training Institute, Jammu/ ATI, Srinagar. During the

training period they shall be entitled to stipend as admissible under rules.

The selectees shall report to the Principal, Northern Zonal Accountancy Training Institute, Jammu/ ATI, Srinagar within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

1. Academic/Technical Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate issued by Competent Authority.
4. Permanent Resident Certificate.
5. Relevant Category Certificate.
6. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

In case the selectees fail to join within the stipulated period of 21 days, their selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
- (b) The verification of all required certificate viz; Academic Qualification Certificates, Date of Birth Certificates, Health Certificates, Permanent Resident Certificates, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointees from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.



After successful completion of one year's ACC training at Northern Zonal Accountancy Training Institute, Jammu, they shall be formally placed as Accounts Assistant in PB-1, ₹5200-20200 + Grade Pay ₹2800 against the post of Accounts Assistants. Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of Jammu and Kashmir Civil Service Regulations Volume-II and "Kashmir Subordinate Accounts Service, Rules".


