They shall be allowed the pay in the Pay Band PB-1, ₹ 5200-20200 + Grade Pay ₹ 2800 in terms of SRO 93 dated 15.04.2009, read with SRO 266 dated 31.08.2009 from the date they actually join in the office of the Director, Accounts & Treasuries, Kashmir.

Their Annual Increment shall be governed in terms of the provisions laid down in SRO 160 dated 10.05.2006 till they qualify the A.C.C Examination to be conducted by the J&K Public Service Commission.


