Whereas, among others, Shri Rajan Balwal, S/o Ashok Kumar, R/o Dhandel Ramnagar Udhampur has been selected as Accounts Assistant (Apprentice) in District Cadre Udhampur under RBA Category by the J&K Services Selection Board vide their No. SSB/Secy/ Sel/2016/ 1849A-9 dated 04.07.2016;

Whereas, recommendation in respect of the said candidate was kept withheld by the Services Selection Board subject to production of Valid RBA Certificate;

Whereas, the Secretary, J&K Services Selection Board vide his letter No. SSB/Sel/ Secy/ 2017/561-63 dated 12.01.2017 has conveyed that the recommendation in favour of Shri Rajan Balwal, S/o Ashok Kumar, R/o Dhandel Ramnagar Udhampur is released.

Consequent upon release of recommendation by the J&K Services Selection Board, Jammu vide their communication referred to above, **Shri Rajan Balwal, S/o Ashok Kumar, R/o Dhandel Ramnagar Udhampur** is deputed for undergoing one year's Accounts Clerk's Course Training (six month's theoretical and six month's practical) in Northern Zonal Accountancy Training Institute, Jammu. During the training period he shall be entitled to stipend as admissible under rules.

The selectee shall report to the Principal, Northern Zonal Accountancy Training Institute, Jammu, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

1. Academic/Technical Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate issued by Competent Authority.
4. Permanent Resident Certificate.
5. Relevant Category Certificate.

6. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

In case the selectee fails to join within the stipulated period of 21 days, his selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.
- (b) The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training at Northern Zonal Accountancy Training Institute, Jammu, he shall be formally placed as Accounts Assistant in PB-1, ₹5200-20200 + Grade Pay ₹2800 against the post of Accounts Assistant. His services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of Jammu and Kashmir Civil Service Regulations Volume-II and "Kashmir Subordinate Accounts Service, Rules".
