Pre-check of Service Books of the retiring Government Employees.

Sir,

As a sequel to the Government Order No. 283-F of 2011 dated 13.12.2011 (copy enclosed) and as a special gesture, the Accountant General (A&E) , J&K, will be deputing a team of ten to fifteen officers, from $15^{\rm th}$ to $20^{\rm th}$ October, 2012, from his office for on the spot pre-check of the Service Books of the government employees, belonging to Leh and Kargil districts who will be retiring within coming two years or so and also of those whose pension cases are still in the process of examination in his office. The programme of the team shall be as under :-

- 2. It is ,accordingly, requested that wide publicity in this regard be got carried out, both in print and electronic media, so as to make all the Government employees of your respective districts, retiring in coming two years or so, aware about the visit of Accountant General's team for pre-check of their Service Books so that no difficulty on this account is faced by them at the time of retirement.
- 3. It is also requested that appropriate arrangements for stay of the Accountant General's team members at Leh and Kargil be got made under an intimation to this office. The team will be arriving Kargil by road on 14^{th} evening and leaving Kargil by road for Leh on the morning of 17^{th} to reach Leh on the same evening. The team will leave back from Leh to Srinagar/ Jammu on 20^{th} October afternoon or early morning of 21^{st} October, as per the availability of air service from there.
