Whereas, among others, selection of 10 candidates, listed in Annexure- A to this order, was repeated in more than one District or District and State Cadre or vice-versa by the Services Selection Board vide their Nos. referred to above;

Whereas, option has been obtained from them with regard to preference of their selection in a particular District/State Cadre vide this office Notification No. DGAT/E-III/G-21/82 dated 21.05.2015 in light of recommendations of the J&K Services Selection Board and the option so sought was to be communicated by them to the Directorate General of Accounts & Treasuries, J&K by 30th of May, 2015;

Whereas, these 10 candidates have exercised their option with regard to their selection in a particular District or State Cadre indicated against each in Annexure-A to this order.

Consequent upon exercise of their option and as recommended by the J&K Services Selection Board, Jammu vide communications referred to above, these 10 selectees/candidates (listed in Annexure-A to this order) are deputed for undergoing one year's Accounts Clerk's Course (ACC) Training (six month's theoretical and six month's practical) in Northern Zonal Accountancy Training Institute, Jammu/Accountancy Training Institute, Srinagar, as indicated against each. During the training period these candidates shall be entitled to stipend as admissible under rules.

After successful completion of one year's ACC training at Northern Zonal Accountancy Training Institute, Jammu/Accountancy Training Institute, Srinagar, they shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800 against the posts of Accounts Assistants. Their services shall be regulated under the "Rules for Admission in the Accountancy

Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of Jammu and Kashmir Civil Service Regulations Volume-II and "Kashmir Subordinate Accounts Service, Rules".

The selectees shall report to the Principal, Northern Zonal Accountancy Training Institute, Jammu/Accountancy Training Institute, Srinagar, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

1. Academic/Technical Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate issued by Competent Authority.
4. Permanent Resident Certificate.
5. Relevant Category Certificate.
6. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

In case any selectee fails to join within the stipulated period of 21 days, his/her selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his/her appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
- (b) The verification of Qualification Certificates/Reserved Category Certificates (wherever applicable) from the concerned issuing authority.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.


