**C I R C U L A R**

In terms of Rule 17.5 & 8.10 of Jammu & Kashmir Financial Code Volume -I the copies of the Government Orders/ sanctions relating to sanctioning of expenditure , receipts , revision of pay scales, creation/ abolition of the establishment , execution of rate contracts for execution of works and higher value purchases etc are required to be endorsed to the Principal Accountant General (Audit) and Accountant General (A&E) , Srinagar /Jammu. These sanctions are required by the Principal Accountant General (Audit) and the Accountant General (A&E) to monitor the provision of funds and observance of standing rules / procedures and the orders of the competent authority.

Despite issuance of circular instructions from time to time in this regard by the Finance Department, a most of the departments have not included the name of Principal Accountant General (Audit) and Accountant General (A&E) in the standard list of endorsements and other mailing lists.

All the Administrative Secretaries are , as such, requested to kindly impress upon the subordinate offices under their administrative control to ensure that the copies of all the sanctions are invariably endorsed and actually sent to the office of Principal Accountant General (Audit) and Accountant General (A&E).
