Subject:- Monthly status update on implementation of National Pension System (NPS) in State Autonomous Bodies (SABs) of Jammu & Kashmir.

CIRCULAR

The NSDL e-Governance Infrastructure Limited, Mumbai has regularly been providing the monthly status/ update on implementation of National Pension system in State Autonomous Bodies (SABs) of Jammu & Kashmir. The latest letter on the subject has been received on 06.08.2018 whereunder, progress made by the SABs regarding such implementation has been intimated.

2. The following issues have been pointed out by the NSDL e-Governance Infrastructure Ltd. which need immediate attention:-

- I. Service Charges amounting to Rs. 2,27,921= are awaiting clearance from 21 SABs.
- II. The SABs namely Additional Provident Fund Commissioner Kashmir & J&K Academy of Art Culture & Languages, Srinagar need to upload contributions regularly/ in a time bound manner.
- III. Against 3246 PRANs associated with SABs out of which 117 PRANs have not received a single credit (Regular or Arrear) since the PRAN generation.
- IV. Pendency of Withdrawal claims due to awaited action by the SABs.
- V. Certain grievances are pending with J&K State Power Development Corporation.
- VI. Reconciliation required to be made of NPS transactions under Error Rectification Module (ERM).

3. In view of the observations/ concerns raised by the NSDL e-Governance Infrastructure Limited, all the Controlling Officers of State Autonomous Bodies (SABs) concerned (as given in Annexure to this Circular) are requested to immediately ask the concerned to address the issues under intimation to this office as well as NSDL.
