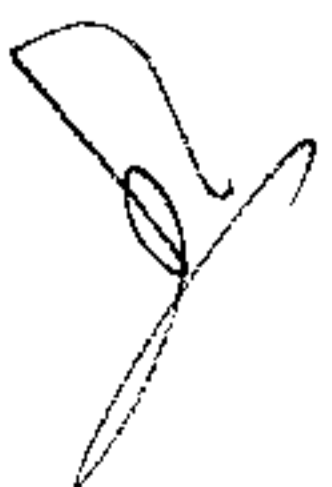
Sub : Deployment of Accounts Officers (Probationer) on on-the-job practical training.
