Provision of terminal payments in the event of untimely death of

an employee under New Pension Scheme.

Sir,

You are aware that the New Pension Scheme for the Government employees has been introduced in the State of Jammu & Kashmir w.e.f. 01.01.2010 , vide SRO 400 dated 24.12.2009. Certain Clauses and Sub-Clauses had been notified in the said SRO for implementation of the New Pension Scheme. However, as per Sub — Clause (w) of Rule 05 of SRO 400 dated 24.12.2009 it was inter-alia provided that :-


"No withdrawal of any amount shall be allowed. Provisions regarding terminal payments in the event of untimely death of an employee or in the event of his leaving the Government Service shall be notified in due course of time."

Pertinent to mention here that in the meeting held on 28.09.2012, the Executive Vice President, NSDL e-Governance Infrastructure Limited Mumbai provided a copy of communication dated September, 10, 2012 wherein the withdrawal guidelines were provided to this Department (copy enclosed for ready reference).

Certain departments were also approaching this Directorate / Finance Department for settlement of cases of terminal benefits in respect of the employees who die while in service or leave the Government service appointed on or after 01.01.2010.

Since , it was clearly mentioned in the Sub-Clause (w) of Rule 05 SRO 400 that provisions regarding terminal payments shall be notified in due course of time. As such, the Codes Section of Finance Department was approached for issuance of necessary guidelines, in this behalf.

Now vide SRO 226 dated 22nd April, 2013 the withdrawal guidelines have notified and the Clause (w) of Rule 5 of the Jammu and



Kashmir Civil Service (Defined contributory Pension Scheme) Rules, 2010 contained in Schedule XXIII of Annexure "A" appended to Article 249-M (B), Chapter XIX-AA has been deleted and after Clause (v) of the said rule, rule 6 the has been added. A copy of the SRO 226 is enclosed for ready reference.

You are , therefore , advised to pass on the copy of the SRO to the Treasury Officers of your respective jurisdictions. They may also be advised to educate the DDOs operating upon their treasuries, so that there is no ambiguity while dealing with the cases of the terminal benefits in respect of the kiths and kins of the employees appointed on or after 01.01.2010 , who die while in service or leave the Government service.

SRO 226 .- In exercise of the powers conferred by proviso to section 124 of the Constitution of Jammu and Kashmir, the Governor is pleased to direct that the following amendments be made in the Jammu and Kashmir Civil Service Regulations, namely:-

Clause (w) of Rule 5 of the Jammu and Kashmir Civil Service (Defined Contributory Pension Scheme) Rules, 2010, contained in Schedule XXIII of Annexure "A" appended to Article 249-M(B), Chapter XIX-AA under the caption 'Defined Contributory Pension Scheme' shall be deleted and after clause (v) of the said rule the following shall be added as rule 6.-

"Rule 6. Withdrawal Guidelines.

- i. In case of retirement (superannuation), if the subscriber wishes to nominate more than one person as his/her nominee, the subscriber shall fill up the additional nominee form i.e; Form 101-GS (and mention the details of the additional nominees) with a remark in the nominee section of the main form. (Annexure: Form 101-GS)
- ii. In case of death, if more than one nominee is present, all the nominees shall fill up separate forms i.e; Form 103-GD and submit the same through the associated DTO to CRA. In case the number of nominees present in the CRA system, is different from the number of nominees from whom the forms are received, the nominees shall present a legal heir certificate for claiming the accumulated NPS proceeds. (Annexure: Form 103-GD)

iii. In case of premature Exit (resignation), if the subscriber wishes to nominate more than one person as his/her nominee, the Subscriber shall fill up the additional nominee form i.e; Form 102-GP (and mention the details of the additional nominees) with a remark in the nominee section of the main form. (Annexure: Form 102-GP)

However, in case of the technical resignation of a Government servant, the withdrawal requests will not be processed".
