CIRCULAR

It has been observed that there is a surge in number of cases, recommended by various departments/offices for sanction of LTC / Leave of various kinds / permission to visit abroad in favour of officers/ officials of the Finance Department, posted in these Departments.

As the last quarter of the financial year has commenced, the availability of officers/ officials to ensure timely scrutiny and disposal of financial matters and observance of financial canons, codal provisions and government instructions for enforcing fiscal discipline is essentially required. The absence of these officers during this crucial period would impact the achievement of fiscal and physical targets for programme implementation, work execution and revenue collection in the departments.

Accordingly, all the officers/officials of the Finance Department are advised to avoid proceeding on long Leave / LTC/ Foreign visits during the last quarter of the financial year, especially during the month of March, except the cases pertaining to medical /maternity leave, pilgrimage and any other extreme exigencies. Any violation will be construed as deliberate escapism from duties and marked for action, as warranted.



All Administrative Departments/ Heads of Departments and District Level Officers are enjoined upon to take these circular instructions into consideration while sanctioning /recommending Leave of the Finance officers posted in these departments/ offices.
