Whereas Managing Director, JKPCC Ltd. vide his Order No. 62 of 2023 dated 08.09.2023 placed Shri Satender Singh Accounts Officer under suspension with immediate effect for remaining unauthorized absent.

Whereas Managing Director, J&K PCC Ltd. was requested vide this Office Letter No. DGAT-CAE/PF/41/2023-01/7285662/290 dated 14.09.2023 to provide the copy of approval of the competent authority under which Sh. Satender Singh, Accounts Officer, JKPCC Ltd. was placed under suspension. However no reply from the concerned quarter has been received till dated.

Whereas Shri Satender Singh Accounts Officer represented this office vide his representation dated 08.09.2023 with the request to revoke the said order on the ground that he had applied for two days casual leave w.e.f. 08.09.2023 to Financial Controller (FC) and application was forwarded by Financial Controller (FC) JKPCC Ltd. to DGM (Adm.) at 11:37 am through e-office for necessary action.

Whereas the officer is on deputation to JKPCC Ltd. from Finance Department and the powers to place an officer under suspension vest with the appointing authority in this case being Finance Department.

Whereas the suspension order issued by the Managing Director JKPCC Ltd. is not in consonance with rules and regulations in vogue besides without approval of the competent authority.


In view of the above and in the interest of administration office Order No. 62 of 2023 dated 08.09.2023 issued by Managing Director JKPCC Ltd. is treated as void ab-initio.
