**Subject: Reimbursement of Pension/Family Pension to Ex-Legislatures of Union Territory of Ladakh.**

**Government Order No. 17 -F of 2022**  
**D A T E D: 25 .01.2022**

In pursuance to the G.O No. 5662-JK (LD) of 2021 dated 08.12.2021, issued by the Department of Law, Justice & Parliamentary Affairs, sanction is hereby accorded to the:-

- i) Nomination of Civil Secretariat Treasury as Nodal Treasury for claiming reimbursement on account of disbursement of Pension/ Family Pension in respect of Ex. Legislators belonging to the UT of Ladakh.
- ii) J&K Bank to act as Pension Disburser on behalf of J&K Government for drawal of pension/family pension in favour of Ex. Legislators belonging to UT of Ladakh and claim its reimbursement from the Government of Jammu and Kashmir through Civil Secretariat Treasury J&K.
- iii) Director Accounts & Treasuries UT of Ladakh, to designate Nodal Officer/s in Leh and Kargil for transfer of left-out Ex. Legislator pensioners / family pensioners to the J&K Bank.
- iv) Finance Department (Budget Division) to make additional budgetary provision for disbursement of pensionary benefits to these pensioners.
- v) All other terms and conditions as applicable to Ex. Legislator pensioners/family pensioners shall be observed by the CST / J&K Bank while disbursing the pension/family pension.
