The placement of these Accounts Assistants as I/C Accountants shall not confer any right on them for regularization as members of Jammu and Kashmir Subordinate Accounts Service Class-II (Accountants) which shall be subject to the recommendations of the Departmental Promotion Committee and shall be subject to outcome of Writ Petition(s), if any, pending disposal in any Court of Law on the subject.
