Whereas in pursuance to Rule 5(c)(vi) of Schedule XI of the Jammu and Kashmir Civil Service Regulations, 26 Junior Assistants, listed in Annexure-A to this Order, of various Departments were permitted to appear in A.C.C. Examination vide Government Order Nos. indicated against each on the recommendations of their concerned Administrative Departments;

Whereas, these Jr. Assistants qualified the A.C.C. Examination as per the Jammu and Kashmir Public Service Commission's Notification Nos. referred to above;

Whereas, these Jr. Assistants were recommended for their encadrement in the Kashmir Subordinate Accounts Service - Class-III (Accounts Assistants) by their concerned Administrative Departments vide their communications indicated against each; and

Whereas, their cases were examined and found to have attained the eligibility for encadrement in the Kashmir Subordinate Accounts Service - Class-III (Accounts Assistants) in terms of Rule 5(c)(vi) of Schedule XI of the Jammu and Kashmir Civil Service Regulations, Vol-II.

Now, therefore, in pursuance of Rule 5(c)(vi) of Schedule XI of the Jammu and Kashmir Civil Service Regulations Vol-II, these 26 Junior Assistants are hereby encadred in the Kashmir Subordinate Accounts Service, Class-III as Accounts Assistants in Pay Band 1, ₹5200-20200 + Grade Pay ₹ 2800.

*It is further ordered that:-*

- a) *the period of 18 months of their eligibility to appear in SAC-I Examination laid down in Rule 5(c)(i) of Schedule XI of Jammu and Kashmir Civil Service Regulations, shall be*

*reckoned from the dates of their joining against the posts of Accounts Assistants;*

*b) their inter-se-seniority in Class-III (Accounts Assistants) in the Kashmir Subordinate Accounts Service shall be fixed separately; and*

*c) the Jr. Assistants so encadred shall report in the Directorate General of Accounts & Treasuries, J&K, Jammu/ Directorate of Accounts & Treasuries, Jammu/ Kashmir as indicated against each for further posting within 21 days from the date of issuance of this Government Order failing which their encadrement in the Kashmir Subordinate Accounts Service shall be deemed to have been cancelled ab-intio;*
