Permission is hereby granted in favour of Mr. Kavneet Singh, Orderly, Directorate General of Accounts & Treasuries, J&K for pursuing Bachelor of Arts (B.A) through distance mode subject to following terms and conditions:-

- i. The Official shall pursue his Bachelor of Arts (B.A) before and after the normal working hours of the office and holidays.
- ii. The completion of the course shall be without detriment to the efficient discharge of his official duties.
- iii. The official shall not use the permission as a pretext for seeking or resisting transfer that may be ordered in his case at any point of time.
- iv. The official shall not claim any scholarship from the University during or after completion of his BA course.
- v. The permission shall not entitle him to claim leave either for preparation or for the duration of the examination and that leave, if any required for the purpose will be sanctioned subject to its admissibility and also administrative interest, in term of rules.
- vi. If at any stage, it is detected that the official has been pursuing the studies during office hours, the permission shall be deemed to have been withdrawn besides, inviting disciplinary action.
- vii. The official shall pursue Bachelor of Arts (B.A) from a recognized Institute only after permission has been granted in his favour.
- viii. If at any stage it is found that the official was not entitled to seek permission for pursuing the course, the permission shall deemed to be withdrawn abinitio.
