**Subject: Fixation of Seniority in favour of Ms. Nameesha Dogra, I/C Senior Scale Accounts Officer.**

Whereas, Ms. Nameesha Dogra was appointed to J&K police service vide Government Order No. 2-GAD of 2012, dated 02.01.2012 through Combined Competitive Service Examination and subsequently her Cadre was changed to Jammu and Kashmir Accounts (G) Service vide Government Order No. 15-GAD of 2013, dated 03.01.2013 pursuant to cabinet decision No. 02/01/2013 dated 03/01/2013.

Whereas, Ms. Nameesha Dogra had represented for re-fixing her seniority at appropriate place par with her batch mates appointed to Jammu and Kashmir Accounts (G) Service vide Government Order No. 02 - GAD of 2012 dated 02.01.2012 .

Whereas, the matter was taken up with General Administration Department vide No. DGAT/CAE-398/263, dated 04.03.2015 for fixation of her Seniority in Jammu and Kashmir Accounts (G) Service.

Meanwhile pending clarification from General Administration Department, the seniority of the officer was fixed in Jammu and Kashmir Accounts (G) Service at s.No. 276 of the Seniority List issued vide Government Order No. 19-F of 2016, dated 20.01.2016


Whereas General Administration Department vide communication number GAD(Ser)Genl/16/2012 dated 03.03.2017 conveyed that seniority of Ms. Nameesha Dogra in Jammu and Kashmir Accounts (G) Service be fixed below Mr. Avinash and above Ms. Neha Thapa.

Whereas, on the recommendations of the General Administration Department, seniority of Ms. Nameesha Dogra was accordingly fixed below Mr. Avinash and above Ms. Neha Thapa.

Whereas, case of the officer alongwith other counterparts was placed before JKPSC/DPC for their regularization as Senior Scale Accounts Officer.

Whereas, the JKPSC/DPC in its meeting held on 14.01.2022 have kept the Regularization of the Officer as Senior Scale Accounts Officer with held and recommended that her seniority be fixed below Mr. Avinash and above Ms. Neha Thapa at S.No. 226-A instead of SI. No. 276 in the Seniority List issued vide Government Order No. 19-F of 2016 dated 20.01.2016.

Now, therefore, in view of the above facts, seniority of Ms. Nameesha Dogra, I/C Senior Scale Accounts Officer is re-fixed retrospectively from the date of issuance of


