4. The Official shall not claim any scholarship from the University during or after completion of his course.
5. The permission shall not entitle him to claim to leave either for preparation or for the duration of the examination and that leave, if any required for the purpose will be sanctioned subject to its admissibility and also administrative interest, in terms of rules.
6. If at any stage, it is detected that the official has been pursuing the studies during office hours, the permission shall be deemed to have been withdrawn besides, inviting disciplinary action.
7. The permission is granted on the assumption that it shall not impact the functioning of the official in any way.
8. If at any stage it is found that the official was not entitled to seek permission for pursuing the course, the permission shall be deemed to be withdrawn ab-initio.
