Sanction is hereby accorded to the temporary appointment of Mst. Gowhara Rafiq Wd/o Late Mohammad Rafiq Hajam R/o H. No. 50, Green Colony Larve, Kakapora District Pulwama, as Class-IV (MultiTasking Staff) with Pay Level SL-1 (14800- 47100) in the Accounts & Treasuries Organization of Finance Department, on compassionate grounds under SR0-43 of 1994.

The appointee shall report to the Director Accounts & Treasuries, Kashmir within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of following documents/ certificates (in original) to be verified subsequently:-

- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Domicile Certificate.
- iv. Health Certificate from the concerned Chief Medical Officer of the District.
- v. Dependent Certificate issued by the Assistant Commissioner, Revenue.
- vi. Certificates from the District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under self employment scheme has been taken by the appointee.
- vii. All other relevant documents as are required under SR0 43 of 1994.

The appointment of the candidate shall further be subject to the following conditions:-

- a. That she shall give an undertaking in the shape of an Affidavit to the effect that if her qualification certificate, on verification/ re-verification from the concerned issuing authority is found fake/ forged, her claim for appointment shall be deemed to have been cancelled ab-initio and the legal action as warranted under rule shall be initiated against her.
- b. The salary of the appointee shall be drawn and disbursed to her only after receipt of satisfactory report in respect of (a) above in her favour.

- c. The appointment of the candidate shall be governed by the "New Pension Scheme, in terms of SRO 400 of 2009 dated 24.12.2009 as amended from time to time.
- d. If the appointee fails to join within a period of 21 days from the date of issuance of this order she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.


