Consequent upon completion of one year's ACC training (six month's theoretical and six month's practical) in Accountancy Training Institute, Srinagar **32** Accounts Assistants (Apprentices), listed in **Annexure- "A"** to this order, selected by the J&K Services Selection Board vide their No. referred to above under Hon'ble Prime Minister's Special Package for Kashmiri Migrants, are hereby placed against the posts of Accounts Assistants and they shall report in the office of the Director, Accounts and Treasuries, Kashmir for their posting/adjustment in their respective Home Districts (Pre- Migration) after getting properly relieved from the concerned Training Institute .

They shall be allowed the pay in the Pay Band PB-1, ₹5200-20200 + Grade Pay ₹2800 (except the in-service candidates drawing higher pay) in terms of SRO 93 dated 15.04.2009, read with SRO 266 dated 31.08.2009 from the dates they actually join in the office of the Director, Accounts & Treasuries, Kashmir .

Their Annual Increments shall be governed in terms of the provisions laid down in SRO 160 dated 10.05.2006 till they qualify the A.C.C Examination to be conducted by the J&K Public Service Commission.


