Subject:- Compassionate Appointment under SRO-43 of 1994 of Mr. Sameer Abass S/o Late Mohammad Amin Mir, Ex- orderly Additional Treasury Tankipora, R/o Kralpora Jaffarbeigh Hawal, Srinagar

In terms of J&K, Compassionate Appointment Rules, 1994 notified vide SRO-43 dated. 22.02.1994 read with SRO-177 of 2014 dated. 20.06.2014 and clarification conveyed by GAD vide U. O No GDC-132/CM/06/SRO dated 04-06-2006; sanction is hereby accorded to the deputation of Mr. Sameer Abass S/o Late Mohammad Amin Mir, Ex- orderly Additional Treasury Tankipora, R/o Kralpora Jaffarbeigh Hawal, Srinagar to Accountancy Training Institute, Srinagar for one year's ACC training (six month's theoretical and six month's practical).


During one year's ACC training period the candidate shall be entitled to stipend as admissible under rules. He shall report in the Training Institute within 21 days from the issuance of this order alongwith the following certificates/documents in original:-

- I. Academic Qualification Certificate.
- II. Date of Birth Certificate.
- III. Permanent Resident Certificate.
- IV. Health Certificate.
- V. NDC from District Employment Officer/District Industries Centre concerned.

In case the appointee fails to join within the stipulated period of 21 days, his appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- a) The appointee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.

- b) The verification of all required cert Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Certificate from General Manager District Industries Centre Srinagar and Deputy Director Employment , to the effect that No loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal Accountancy Training Institute Srinagar.

The stipend of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's training at Accountancy Training Institute, Srinagar he shall be formally placed as Accounts Assistant in the PB-1 Rs. 5200-20200 + Grade Pay Rs. 2800. His services shall be regulated under the provisions of "Rules for Admission in the Accountancy Training School for the various Accountancy Courses and Examinations thereof" laid down in the Schedule XI of J&K CSRs Vol-II and "Subordinate Accounts Services Rules"
