In case the appointees fail to join within the stipulated period of 21 days, their appointment shall stand cancelled without any further notice.

Their services shall be governed in terms of SRO 202 dated 30-06- 2015.

The appointment shall be subject to the following conditions:-

- a) the appointee shall give an undertaking to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment; and
- b) the verification of all required Certificates viz, Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Certificate from General Manager District Industries Centre and Deputy Director Employment of concerned District, to the effect that No loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the respective DDO.
