Sanction is hereby accorded to the up-gradation of 07 posts of Head Assistants carrying the Pay Band (Rs.9300-34800) + Grade Pay Rs. 4200 to the posts of Sectional Officers carrying Pay Band(Rs.9300-34800) + Grade Pay Rs. 4600 and subsequent placement of below mentioned 07 Head Assistants as per seniority in their own Pay Band and Grade Pay with Charge Allowance as admissible under rules with immediate effect.

The posts so upgraded shall be held by the incumbents in their personal capacity by corresponding reduction of equal number of posts of Head Assistants in the inter-organizational seniority and these posts shall revert back to original positions once these incumbents retire on superannuation from the Government service:-
