Whereas, vide J&K Service Selection Board's No. referred to above, 08 candidates were recommended for appointment against the posts of Jr. Scale Stenographers (Finance Department), State Cadre under SRO 202 dated 30-06-2015;

Whereas, vide Government Order No: 342-F of 2017 dated 17-11-2017 issued under endorsement No DGAT/HQ/Mint/PS/DR/377 dated 17-11-2017, appointment orders in respect of all the 08 selected candidates were issued and they were ordered to report to the Director, Accounts & Treasuries, Kashmir/Jammu for further duties with the condition that in case the appointees fail to join within the period of 21 days, their appointment shall stand cancelled without any further notice;

Whereas, the Director, Accounts & Treasuries Jammu/Kashmir vide their Nos. DATJ/Adm/2017-18/6281, dated 13.03.2018 and DATK/Adm-II/383, dated. 10.01.2018, respectively, intimated that out of these 08 selectees, only 02 candidates have reported in their offices and the remaining 06 selectees listed in Annexure-"A" to this Order failed to join within the stipulated period of 21 days;

Whereas, the appointment of the selectees, who failed to join within the prescribed period is likely to cancellation in terms of the orders of appointment issued vide Government Order No 342-F of 2017 dated 17-11-2017.

Now, therefore, sanction is hereby accorded to the cancellation of Selection/Appointment in respect of the 06 candidates, listed in Annexure- "A" to this Order.


