- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

The appointment shall be subject to the following conditions:-

- (a) The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.
- (b) The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.
- (c) The appointment of the candidates shall be governed by the provisions of SRO-202 dated 30.06.2015.
- (d) Their inter-seniority shall be in order in which their names appear in the Government Order which is according to Select List furnished by the Services Selection Board.
- (e) The salary of these appointees shall not be drawn and disburse until and unless a satisfactory report in respect of (a) and (b) above are received in his/ her favour.

The appointee shall report to the respective head of the offices within a period of 21 days from the date of issuance of this order. In case any appointee does not join within the stipulated period his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.
