- VI. All other relevant document as are required under SRO-43/1994.

The appointee shall be initially on probation for a period of two years. If, on verification, the certificates produced by the appointee prove to be false or forged, the appointment shall be cancelled ab-initio. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedent is received from Inspector General of police, CID to whom a reference shall be made by the Directorate General of Audit & Inspection J&K, Jammu.
