Subject:- Creation of posts of Accounts Assistants in Panchayats.

Reference:- State Administrative Council Decision No. 51/7/2019 dated 28.02.2019.

**Government Order No. 373-F of 2019
Dated : 27.06.2019.**

Sanction is hereby accorded to:

- a) Creation of 2000 posts of Accounts Assistants exclusively for strengthening the functioning of democratically elected Panchayat Raj Institutions as per the district wise break-up furnished by the Rural Development Department (**Annexure 'A'**).
- b) These Accounts Assistants would bear the nomenclature of Panchayat Accounts Assistants.
- c) Recruitment to be done under SRO 202 under which they will be receiving contractual salary for first five years and thereafter get full regular salary.
- d) Interview to be dispensed within the recruitment process and selection would be made by J&K Service Selection Board, based only on merit determined through written test.
- e) Rural Development Department will meet the contractual salary of the selectees from the provisions available for administrative expenses under various schemes administered by it and should there be any shortfall, the same would be met by the Finance Department from its budgetary resources.
- f) These shall be District Cadre Posts and only in extreme circumstances, incumbent can be transferred out of the District with prior concurrence of the Finance Department.
- g) Their transfer will be affected within the block by the BDO and within the District by the DDC on a proposal moved by the ACD.

h) The Performance Appraisal will be done by the Block Development Officer (BDO) concerned, reviewed by the Assistant Commissioner Development (ACD) and accepted by the District Development Commissioner (DDC) concerned.
