Subject:- Stop-gap placement of Assistant Accounts Officers as I/C Junior Scale Accounts Officers.

Government Order No. 144 -F of 2020  
Dated : 11.04.2020.

Sanction is hereby accorded to the placement of following Assistant Accounts Officers of J&K Subordinate Accounts Service as I/C Junior Scale Accounts Officers, purely on temporary basis as a stop-gap arrangement in their own pay and grade, with charge allowance as admissible under rules for a period of six months or till the available vacancies are filled up on regular basis on the recommendations of DPC/PSC, whichever is earlier. This arrangement shall not confer any preferential right to them for consideration of their promotion as Junior Scale Accounts Officers, as and when the same is considered on regular basis and shall be subject to outcome of writ petition(s) if any, pending before any Competent Court(s) of law.


