
Whereas, the General Administration Department vide their No. GAD (Legal)/F-51/2005/299 dated 15.01.2015 forwarded Orders of the Hon'ble High Court dated 23.11.2016 in SWP No. 116/2005 in MP No. 882/2007- Titled Abdul Hamid Kumar Vs State of J&K and Ors.

Whereas, after examination of the case the Department vide U.O. No. DGAT/Legal/HCS-117/151 dated 23.08.2017 forwarded the case of the officer to the General Administration Department for their opinion who vide their U.O. No. GAD(Ser)KAS/Gen/21/99-II dated 15.05.2018 have communicated as under:-

*"The Finance Department is advised to fix the seniority of the petitioner notionally from 12-07-1999 without any monetary benefit as per his order of merit and category and on regular basis prospectively from his actual date of appointment to J&K Accounts (G) Service ordered vide Government Order No. 217-GAD of 2002 dated 02/02/2002, subject to the condition that the officers likely to be affected by this action are put to notice, in the first instance."*

Whereas, as per the merit and category seniority of the officer falls at 4A in between S. No. 4. Mohd. Ayoub Nasir (ST), FA&CAO, J&K Industries Ltd. and S. No. 5 Seema Bhasin (SC) FA&CAO, Revenue Department in Annexure "C" of the Seniority List of Members of J&K Accounts (Gazetted) Service issued vide Government Order No. 63-F of 2018 dated 26.02.2018 issued under Endorsement No. DGAT/CAE-Misc-01(2018)/PS/DR/79 dated 26.02.2018.

In view of the above and in order to fix the seniority of the officer viz. Sh. Abdul Hamid Kumar, Chief Accounts Officer, Government Medical College, Srinagar at the appropriate place in the Seniority List of the Members of J&K Accounts (Gazetted) Service, Objections, if any are called from the officers likely to get effected within a period of 07 days from the date of issuance of this Notice.
