**Subject:- Fixation of seniority in favour of Sh. Farhat Fayaz Wani, Orderly,
Directorate of Accounts & Treasuries, Kashmir.**

NOTICE

Whereas the Director Accounts & Treasuries Kashmir vide letter No. DATK/Adm-ii/10380 dated 25.07.2018 forwarded representation of Sh. Farhat Fayaz Wani Orderly of his office requesting therein that seniority of the official shall be fixed at correct place in light of merit/ points obtained by the concerned orderly in the selection list.

Whereas after examining the case it has been found that seniority of the Orderlies selected in 2011 has been fixed inadvertently by considering their date of joining instead of Merit / points obtained by them in selection list.

Whereas as per merit /points obtained by Sh. Farhat Fayaz Wani, his seniority comes at S.No.131 instead of S.No.163 in the seniority list issued vide order No. 141-Acctts of 2017 dated 09.06.2017.

Whereas, consequent upon inclusion of Mr. Farhat Fayaz Wani, Orderly in above seniority list dated 09.06.2017 at S.No.131 strictly as per merit and points obtained by him in the selection, the seniority position of the Orderlies from S.No. 128 to 201 as notified vide order No.141-Acctts of 2017 dated 09.06.2017 shall appear as under:-
