The Departmental Invigilators are directed to get the type test conducted on the scheduled dates and time and watch the process very carefully and select the penal according to the merit obtained by each candidate on the criteria of 35 words per minute speed with 90% accuracy and prepared by the Industrial Training Institute, Canal Road, Jammu and submit the resultant report to the Director General, Accounts & Treasuries on 23.03.2018.

The Notification uploaded in the official website/published in the newspaper shall be treated as **Call Letter** and no individual call letters shall be issued.

As notified vide Notification No. DGAT/HQ/EM/148 dated 22.02.2018, orderlies under Prime Minister's Special Package for Return and Rehabilitation for Kashmiri Migrants to Kashmir Valley if qualify requisite type-test shall have to wait for their adjustment till the posts become available in the valley as per the ratio to be fixed by the Department.

No TA/DA shall be paid to the candidates participating in the type-test.


