Sub: Deputation of Accounts Assistant (Apprentice) for one year's ACC Training.

Ref: Secretary, Services Selection Board J&K's letter No. SSB/Sel/Secy/ 2016/1849A-4 dated 04.07.2016.

Whereas, the Services Selection Board, J&K vide their No. SSB/Secy/Sel/2016/1849A-9 dated 04.07.2016, among others, furnished Selection List of 28 candidates (OM = 16, RBA = 06, SC = 02, OSC = 01 and ST = 03) alongwith Waiting List of 08 candidates (OM = 05, SC = 01, OSC = 01 and ST = 01) for District Kathua;

Whereas among these 28 selected candidates, 22 candidates (OM=12, RBA=05, SC=01, OSC=1 and ST=3) were deputed to NZATI, Jammu for undergoing one year's ACC training vide this office Order No. 198-Accts of 2016 dated 06.09.2016;

Whereas, the deputation order in respect of 06 candidates (OM=04, RBA =01 and SC=01) were not issued as recommendations in respect of these candidates were kept withheld by Services Selection Board;

Whereas, Services Selection Board vide their No. SSB/Secy/Sel/2016/19875-77 dated 28.09.2016 released the recommendations in respect of 04 candidates (OM = 03 and SC = 01).

Whereas, these candidates were deputed for one year's ACC training to NZATI, Jammu vide Order No 231- Accts of 2016 dated 20.10.2016;

Whereas, out of 15 selected candidates under OM Category who were deputed for one year's ACC training only 13 candidates joined in the NZATI, Jammu as intimated by the Principal NZATI, Jammu vide Nos. A/Zonal/J/2015/580 dated 30.09.2016 and A/Zonal/J/2017/1614-15 dated 09.01.2017;

Whereas, the remaining 02 candidates under OM category did not join in the training Institute and subsequently Waiting List was operated and two candidates from Waiting List under OM Category, namely, Shri Amrit Jasrotia S/o Dilbagh Singh and Shri Saurav Khajuria S/o Sudesh Kumar figured at S.No 1 and 2 were deputed for undergoing one year's ACC training to NZATI, Jammu, vide Order No. 255- Accts of 2016 dated 06.12.2016, who joined in the said Institute on 13.12.2016 and 09.12.2016 respectively as informed by Principal NZATI, Jammu vide No. A/Zonal/J/ 2017/ 1614-15 dated 09.01.2017;

Whereas the Services Selection Board, J&K Vide Order No. 159 SSB of 2017 dated 17.04.2017 cancelled selection of Shri Nitin Gupta S/o Surinderpaul Gupta under OM Category in District Kathua as the selectee did not deposit the requisite documents within stipulated time;

Whereas upon cancellation of selection of Shri Nitin Gupta S/o Shri Surinderpaul Gupta, one post of Accounts Assistant has fallen vacant in District Kathua, under OM Category against which Shri Suhail Ahmed S/o Shri Iqbal Ahmed R/o Ward No. 2 Kathua figuring at S.No. 3 in Waiting List recommended by Services Selection Board in District Kathua under OM Category becomes eligible for his deputation to undergo one year's ACC training in NZATI, Jammu.

Now in view of above, sanction is hereby accorded to the deputation of **Shri Sohail Ahmed S/o Shri Iqbal Ahmed R/o W.No 2 Kathua, recommended by the Services Selection Board under OM Category in the Waiting List for District Kathua for undergoing one year's ACC training in Northern Zonal Accountancy Training, Institute, Jammu.**

During the training period he shall be entitled to stipend as admissible under rules.

After successful completion of one year's ACC training in Northern Zonal Accountancy Training Institute, Jammu he shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800. His services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".

The selectee shall report to the Principal, Northern Zonal Accountancy Training Institute, Jammu within a period of 21 days from the date of issuance of this order alongwith the following certificates/ documents in original:-



- i. Academic Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case any selectee fails to join within the stipulated period of 21 days, his appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.
- (b) The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.
