
Whereas, among others, Shri Harbans Lal, S/O Krishan Chand R/o Bakhan Chak Ramgarh Samba and Shri Satish Sharma, S/O Parmanand Sharma R/O Nardi Bala Akhnoor Jammu, Accounts Assistants (Apprentices) has been selected as Accounts Assistant (Apprentice) in Districts Shopian/ Pulwama and Jammu under SC and RBA Category respectively by the Services Selection Board vide their No.s referred above;

Whereas, recommendations in respect of these two candidates were kept withheld by the Services Selection Board subject to clarification from Competent Authority with regard to production of Bonafide certificate/ valid of graduation Certificate.

Whereas, the Secretary, J&K Services Selection Board vide his letter Nos. SSB/H-6/16/443-46/18 dated 02.04.2018 and SSB/Sel/Secy/2018/2208-10 dated 22.02.2018, has conveyed that the recommendations in favour of Shri Harbans Lal, S/O Krishan Chand R/o Bakhan Chak Ramgarh Samba and Shri Satish Sharma, S/O Parmanand Sharma R/O Nardi Bala Akhnoor Jammu, are released.

Consequent upon release of recommendations by the J&K Services Selection Board vide their communications referred to above, **Shri Harbans Lal, S/O Krishan Chand R/o Bakhan Chak Ramgarh Samba and Shri Satish Sharma, S/O Parmanand Sharma R/O Nardi Bala Akhnoor Jammu** are deputed for undergoing one year's Accounts Clerk's Course Training (six month's theoretical and six month's practical) in Northern Zonal Accountancy Training Institute, Jammu. During the training period they shall be entitled to stipend as admissible under rules.

The selectees shall report to the Principal, Northern Zonal Accountancy Training Institute, Jammu, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-



1. Academic/Technical Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate issued by Competent Authority.
4. Permanent Resident Certificate.
5. Relevant Category Certificate.
6. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

In case the selectees fail to join within the stipulated period of 21 days, their selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectees shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about their Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, their appointment shall itself stand cancelled ab-initio and they shall have no claim of their appointment.
- (b) The verification of all required certificate viz; Academic Qualification Certificates, Date of Birth Certificates, Health Certificates, Permanent Resident Certificates, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointees from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectees shall not be drawn and disbursed to them unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training at Northern Zonal Accountancy Training Institute, Jammu, they shall be formally placed as Accounts Assistant in PB-1, ₹ 5200-20200 + Grade Pay ₹ 2800 (Pre-revised)/ Level-5 (29200-92300) against the post of Accounts Assistants. Their services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of Jammu and Kashmir Civil Service Regulations Volume-II and "Kashmir Subordinate Accounts Service, Rules".


