Whereas prosecution was sanctioned against the officer vide Government Order No.40-GAD (vig) of 1997 dated 16.05.1997;

Whereas the official has retired from Government service on superannuation w.e.f. 30.01.2008 from the office of Principal, Higher Secondary School, Khandah, Budgam;

Whereas the Director, Accounts & Treasuries, Kashmir vide No. DATK/Adm-I/2566-67 dated 03.08.2018 recommended to consider the promotion INSITU(s) in favour of the Ex-official;

Whereas the case was accordingly processed and it was decided to place it before the Departmental Promotion Committee for their examination and recommendations;

Whereas the case was placed before the Departmental Promotion Committee in its meeting held on 10.07.2018 for its recommendations;

Whereas the Departmental Promotion Committee examined the case and recommended to grant 1st HSPS in the Scale of Rs.1400-2300 (Pre-revised) and 2nd HSPS in the Pay Scale of Rs.1400-2600 (Pre-revised) w.e.f. 01.01.1995 and 3rd HSPS in the Scale of Rs.5150-8300 (Pre-revised) we.f. 01.04.2000.

Now, in view of the above sanction is accorded to the grant of 1st HSPS in the Scale of Rs.1400-2300 (Pre-revised) and 2nd HSPS in the Pay Scale of Rs.1400-2600 (Pre-revised) w.e.f. 01.01.1995 and 3rd HSPS in the Scale of Rs.5150-8300 (Pre-revised) we.f. 01.04.2000 in favour of Shri Bashir Ahmad Bhat, Ex-Accounts Assistant, Govt. Higher Secondary School, Khandah, Budgam. The pay of the Ex-official shall strictly be governed by the provision of SRO 160 dated 10.05.2006 being an unqualified Accounts Assistant.
