Sub: Deputation of Accounts Assistants (Apprentices) for A.C.C. Training.

Whereas, among others, Shri Aishaq Hussain Mir S/o Gh Moi Ud Din Mir R/o Bun Nambal Babagund Mattan Anantnag was deputed for undergoing one year's ACC training in Accountancy Training Institute, Srinagar, vide Order No. 14- Accts of 2019 dated 21.01.2019;

Whereas, the Accounts Assistant (apprentice) was supposed to join in Accountancy Training Institute, Srinagar within a period of 21 days from the date of issue of the above cited Order;

Whereas, as intimated by the Principal, Accountancy Training Institute, Srinagar, vide letter No. ATI-S/2019/1389 dated 04.07.2019, the selectee failed to join in the training Institute within the stipulated period of 21 days;

Whereas, a notice was issued vide No. DGAT/E-III/G-21/66 dated 12.06.2019 through official website informing the concerned selectee/absentee that consequent upon his failure to join/report in the training Institute, his selection shall be cancelled and the Waiting List furnished by the Services Selection Board shall be operated against his place. The selectee/absentee was also given a chance to file his objection, if any, to this effect within seven days from the date of issuance of the aforementioned notice;

Whereas, no objection has been filed by the concerned absentee/droup-out in this behalf within the stipulated period which made it clear that he has no objection to the cancellation of his selection as Accounts Assistant.

In view of above, sanction is hereby accorded to the:-

- i. **cancellation of selection/deputation for one year's ACC training in respect of Shri Aishaq Hussain Mir S/o Gh Moi Ud Din Mir R/o Bun Nambal Babagund Mattan, Anantnag who failed to join in the training Institute within the stipulated period.**
- ii. **deputation of Shri Showkat Ahmad Bhat S/o Mohd Shaban Bhat R/o Bonadialgam Anantnag, for one year's ACC training in Accountancy Training Institute, Srinagar.**

During one year's ACC training the candidate/selectee shall be entitled to stipend as admissible under rules.


The selectee shall report to the Principal, Accountancy Training Institute, Srinagar, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- i. Academic/Technical Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case the selectee fails to join within the stipulated period of 21 days, his appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.
- (b) The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.



The stipend of the selectee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training in Accountancy Training Institute, Srinagar, he shall be formally placed as Accounts Assistant in level-5 (29200-92300). His services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".
