Sub: Deputation of Accounts Assistants (Apprentice) for one year's ACC Training.

Ref: Secretary J&K Services Selection Board, Jammu's letter No. SSB/Secy/Sel/2018/3094-3100 dated 23.03.2018.

Whereas, among others, Sh. Nishan Singh S/o Sh. Jasbir Singh R/o Dharp Jammu and Sh. Harish Chander S/o Sh. Faqir Chand R/o Malhori Doda were selected by the Services Selection Board for appointment against the posts of Accounts Assistants vide their No. referred to above and were subsequently deputed for undergoing one year's ACC training vide Order Nos. 185-Accts of 2018 dated 25.06.2018 and 230-Accts of 2018 dated 03.08.2018;

Whereas, they were supposed to join in Northern Zonal Accountancy Training, Institute, Jammu within a period of 21 days from the date of issue of the Order;

Whereas, as intimated by the Principal, Northern Zonal Accountancy Training, Institute, Jammu vide Nos. A/Zonal/J/2018/2064-65 dated 19.07.2018 and A/Zonal/J/2018/2570-71 dated 29.08.2018, the selectees have failed to join in the training Institute within the stipulated period of 21 days;

Whereas, a notice was issued vide No. DGAT/E-III/G-21/215 dated 07.12.2018 through print media and official website informing the concerned selectees/absentees that consequent upon their failure to join/report in the concerned training Institute, their selection shall be cancelled and the Waiting Lists furnished by the Services Selection Board shall be operated against their places. The selectees/absentees were also given a chance to file any objections to this effect within seven days from the date of issuance of the aforementioned notice;

Whereas, no objection has been filed by the concerned absentees/drop-outs in this behalf within the stipulated period which made it clear that they have no objection to the cancellation of their selection as Accounts

Assistants, recommended by the Service Selection Board vide their No. referred to above.

In view of above, sanction is hereby accorded to the:-

- i. **cancellation of selection/deputation for one year's ACC training in respect of Sh. Nishan Singh S/o Sh. Jasbir Singh R/o Dharp Jammu and Sh. Harish Chander S/o Sh. Faqir Chand R/o Malhori Doda who failed to join in the training Institute within the stipulated period**
- ii. **deputation of Sh. Deeptanshu S/o Sh. Vimal Balgotra R/o 44-Dhakki Sarajan Jammu in the waiting list under OM Category in District Jammu selected by the Service Selection Board as Accounts Assistant in Finance Department vide its No. referred to above, for one year's ACC training in Northern Zonal Accountancy Training, Institute, Jammu.**

During one year's ACC training the candidate/selectee shall be entitled to stipend as admissible under rules.

The selectee shall report to the Principal, Northern Zonal Accountancy Training, Institute, Jammu within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

1. Academic/Technical Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificate issued by Competent Authority.
4. Permanent Resident Certificate.
5. Relevant Category Certificate.
6. Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that no Loan under Self Employment Scheme has been taken by the appointee.

In case the selectee fails to join within the stipulated period of 21 days, his selection shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- a) The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.



- b) The verification of all required certificate(s) viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manager of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's training at the Northern Zonal Accountancy Training Institute, Jammu, **he shall be placed against the posts of Accounts Assistant with the condition that his service shall be governed under the provisions of SRO 202 dated 30.06.2015.** His services shall be regulated under the provisions of "Rules for Admission in the Accountancy Training School for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".
