Sub: Deputation of Accounts Assistants (Apprentices) for A.C.C. Training.

Ref: Secretary J&K Service Selection Board, Srinagar's letter No:- SSB/Secy/Sel/2018/3094-3100 dated 23.03.2018.

Whereas, among others, **Shri Harish Chander S/o Faqir Chand R/o Malhora Doda** was selected by the Services Selection Board for appointment against the post of Accounts Assistant **under SC Category in District Reasi** vide their No. referred to above,

Whereas, vide Order No. 165-Accts of 2018 dated 29.05.2018 the selectee was deputed for undergoing one year's ACC training in NZATI, Jammu;

Whereas, he was supposed to join in Northern Zonal Accountancy Training, Institute, Jammu within a period of 21 days from the date of issue of the Order;

Whereas, as intimated by the Principal, Northern Zonal Accountancy Training, Institute, Jammu vide their Nos. A/Zonal/J/2018/1915-16 dated 27.06.2018, the selectee failed to join in the training Institute within the stipulated period of 21 days;

Whereas, a notice vide No. DGAT/E-III/G-21/184 dated 17.10.2018 was issued informing the concerned absentee that consequent upon his failure to join/report in the training Institute, his selection shall be cancelled and to file his objection, if any, to this effect within seven days from the date of issuance of the aforementioned notice;

Whereas, no objection has been filed by the concerned absentee in this behalf within the stipulated period which made it clear that he has no objection to the cancellation of his selection.

In view of above, sanction is hereby accorded to the:-

- i. **cancellation of selection/deputation for one year's ACC training in respect of Shri Harish Chander S/o Faqir Chand R/o Malhora Doda who failed to join in the training Institutes within the stipulated period**
- ii. **deputation of Shri Chandan Lal S/o Balak Ram R/o Chhajwal, Akhnoor, selected by the Service Selection Board as Accounts Assistants in Finance Department in Waiting Lists under relevant Categories in Districts Reasi vide its No. referred to above, for one year's ACC training in Northern Zonal Accountancy Training, Institute, Jammu.**

During one year's ACC training the candidate/selectee shall be entitled to stipend as admissible under rules.


The selectee shall report to the Principal, Northern Zonal Accountancy Training, Institute, Jammu, within a period of 21 days from the date of issuance of this order alongwith the following certificates/documents in original:-

- i. Academic/Technical Qualification Certificate.
- ii. Date of Birth Certificate.
- iii. Health Certificate issued by Competent Authority.
- iv. Permanent Resident Certificate.
- v. Relevant Category Certificate.
- vi. Certificate from General Manger of the concerned District Industries Centre and Deputy Director Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee.

In case the selectee fails to join within the stipulated period of 21 days, his appointment shall stand cancelled without any further notice.

The appointment shall be subject to the following conditions:-

- (a) The selectee shall give undertaking in the shape of an Affidavit to the effect that in case any adverse report about his Character and Antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the Department, his appointment shall itself stand cancelled ab-initio and he shall have no claim of his appointment.
- (b) The verification of all required certificate viz; Academic Qualification Certificate, Date of Birth Certificate, Health Certificate, Permanent Resident Certificate, Category Certificate (wherever applicable), Certificate from General Manger of the concerned District Industries Centre and Deputy Director



Employment, to the effect that No Loan under Self Employment Scheme has been taken by the appointee from the concerned Issuing Authority to be got done by the Principal of the training Institute.

The stipend of the selectee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) and (b) above is received.

After successful completion of one year's ACC training in Northern Zonal Accountancy Training, Institute, Jammu, he shall be formally placed as Accounts Assistants in PB-1, ₹5200-20200 + Grade Pay ₹2800. His services shall be regulated under the "Rules for Admission in the Accountancy Training Institute for the various Accountancy Courses and Examinations thereof" laid down in Schedule XI of J&K CSRs Vol-II and "J&K Subordinate Accounts Service Rules".
